1. Applications in the prescribed format are invited from applicants who are qualified as on the last date fixed for submission of applications for recruitment to **22 (Twenty Two) Posts** of Drivers in Karnataka Urban Water Supply & Drainage Board, Bengaluru. Application form may be down loaded from the Board website [www.kuwsdb.org](http://www.kuwsdb.org)

**2. Method of Recruitment:** Selection of candidates will be made in accordance with the Karnataka Civil Services (General Recruitment) Rules, 1977 and as amended from time to time.

**3. Minimum Qualification:**

Must have passed S.S.L.C or equivalent examination and who possess license for driving Heavy Passenger Motor Vehicle or Heavy Goods Vehicle and who have got a minimum of 5 years experience in driving. Further the candidate should have good knowledge of English and Kannada.

**4. Scale of Pay :** 21400-500-22400-550-24600-600-27000-650-29600-750-32600-850-36000-950-39800-1100-42000.

**6. Probation:** The applicant if appointed shall be initially on probation for a period of two years or for such extended period.

**7. Age limit:** Applicants must have attained the age of 18 years and must not exceed the age of (as per Rule 6(1) of the Karnataka Civil Services (General Recruitment) Rules, 1977):-

- (a) 40 years in the case of a person belonging to Scheduled Caste/Scheduled Tribe and Category-I of other Backward classes.
- (b) 38 years in case of persons belonging to Category-II A, II B, III-A, III-B of other Backward classes and
- (c) 35 years in case of others.

As per Rule 6(3) of the Karnataka Civil Services ( General Recruitment) Rules, 1977 Notwithstanding anything contained in Rule 6(1) of the same, the maximum age limit for appointment of a suitable candidate shall be deemed to be enhanced in the following cases to the extent mentioned, namely:-

i. in case of a candidate who is working or was holding a post under the Government or a local authority or a Corporation established by a State Act or a Central Act or established by the Government under a State Act or Central Act and owned or controlled by the Government by the number of years during which he is or was holding such post or ten years whichever is less;

(c) The minimum and maximum age limit will be as on the **last date of submission of application.**

**8. Method of Application and fee:** The method of Application shall be through **off line and the application form can be down loaded from** the website [www.kuwsdb.org](http://www.kuwsdb.org) and sent through Registered Post or by person along with Xerox copy of fee paid challan.

**Applications sent through any mode other than the above will not be considered.**

**Application Fee:**

- For Scheduled Caste, Scheduled Tribe and Category-I candidates - Rs. 50/- (Rupees Fifty only)
- For all other candidates Rs. 250/- (Rupees Two hundred and fifty only)

**Mode of Payment:**

- (i) candidates shall make the payment of application fee through RTGS to Account No.520141001412287 IFSC Code. CORP 0000714. Corporation Bank Jalbhavan Branch Bangalore. Or Send DD in favour of Managing Director KUWS & D Board, Bangalore.

**(ii) Candidates must produce the fee paid challan at the time of verification of original documents.**

Fee once paid will not be refunded under any circumstances.

**9. Criteria for selection:**

- (1) Merit list as per marks obtained in SSLC examination – 25% weightage.
- (2) Marks obtained in Driving Test – 25% weightage.
- (3) Previous service certificates under Government/Reputed Firms or Agencies – 25% weightage.
- (4) Marks obtained in Personality Test – 25% weightage

**10. Candidates Claiming Reservations:**

a) The candidates belonging to SC/ ST/OBC, shall possess the certificate in the form as prescribed by the Government of Karnataka, and issued by the competent Authority.

b) The candidates claiming reservation under Rural / Kannada Medium / shall possess the certificates issued by Competent Authorities.

(c) The candidates claiming relaxation of upper age limit shall produce relevant certificate issued by the competent authority at the time of verification of documents. A copy of the same should be submitted along with the Application form.

(d) The candidates who are in service of Union of India/State Governments and their undertaking shall possess the **“No Objection Certificate”** issued by the Authority and produce the same at the time of verification of documents/further tests. At the same time they shall specifically mention the number of years of holding of office, for claiming age relaxation.

(e) The candidates claiming benefits under Sl. No. 10 (a) to (d) above shall possess the relevant certificates, issued by the Competent Authorities **on or before the last date of submitting application**. A copy of the certificates should be submitted along with the application form.

**11.** At the time of Verification of documents, the candidates shall produce the original documents with regard to Educational Qualification, Date of Birth, and reservation if any claimed with regard to Caste/ Rural /Kannada Medium / along with certificates issued by the competent authority for verification.

**12.** Candidates belongs to Hyderabad Karnataka Region must produce the original eligibility certificate in ANNEXURE-A and residential certificate in ANNEXURE-B issued by the Competent Authority of the concerned District/Taluk, at the time of document verification. A copy of the same should be submitted along with the Application form.

**13.** The candidates shall furnish 3 character certificates (one from the last studied education Institution and 2 from the respectable persons) along with the application form.

**14.** The candidates called for Driving Test /Interview will have to appear for the same at their own cost.


**15.** If a candidate is found attempting to procure extraneous support or influence of any kind for his or her candidature, he/she is liable to be disqualified.

**16.** If the information furnished by the applicant in the application is found to be false, his or her candidature is liable to be rejected and such candidate shall be liable for criminal prosecution.

**17.** Candidates are instructed to read carefully the above instructions before submission of application, prescribed qualification, age criteria, application fee, method of recruitment and all other necessary information.
